

Yamaha Motor Corporation, U.S.A. 2024 Colorado Adventure Ride Contest Rules

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. CONTEST BEGINS AT 8:00 AM EASTERN TIME ("ET") ON 04/09/24 & ENDS AT 5:00 PM ET ON 05/02/24 (THE "PROMOTION PERIOD").

ELIGIBILITY: THE YAMAHA 2024 COLORADO ADVENTURE RIDE CONTEST ("the CONTEST") is open to individual legal residents of the United States (residents of Puerto Rico & other U.S. territories & possessions are excluded), age 21 or older as of the date of entry, except employees (& their immediate families, spouse, parent, child, sibling & their respective spouses, regardless of where they reside) & members of the same household, whether or not related, of Yamaha Motor Corporation, U.S.A. ("SPONSOR"), & its parent, affiliates, subsidiaries, retailers, suppliers, distributors & advertising & promotion agencies. Contest is void in Puerto Rico & U.S. territories & possessions & where prohibited by law & subject to all applicable federal, state & local laws & regulations.

HOW TO ENTER: Entries will be collected via electronic entry by visiting <https://yamahamotorsports.com/Content.php?content=2024-Colorado-Adventure-Trip-Entry> during the Promotion Period where a copy of these rules are available for each entrant to review & keep. Participants must submit either a :30 second video story or written story with images that best depict their passion for Yamaha and Adventure. Entries must be received before the CONTEST close deadline (05/02/24 at 5:00PM ET). No incomplete, inaccurate or altered entries or entries that have been generated by script, macro or other automated means will be accepted. All entries become the exclusive property of Sponsor & will not be acknowledged or returned. Limit one (1) sweepstakes entry per person, per household & per email address for the entire Promotion Period. All eligible entries collected during the Promotion Period will be included in the judging. Any video, photo or statement submitted as part of your entry in the Contest (an "Entry Submission") shall automatically be deemed non-confidential. By providing an Entry Submission, you expressly grant Yamaha a royalty-free, perpetual, irrevocable, nonexclusive, worldwide license to use, reproduce, modify, publish, edit, translate, distribute, perform, display, and make derivative works of such material provided in the Entry Submission, in whole or in part, and in any form, media or technology, whether now known or hereafter developed, and further including the unfettered right to sublicense such rights. SELECTION OF WINNER: All Entry Submissions received by Sponsor during the Contest Period will be judged by a panel of qualified judges based on the following criteria to determine the top (6) entries for the Wolverine RMAX trip and the top (6) entries for the Tenere 700 trip: originality, creativity, and expression of passion for Yamaha and Adventure. Judges' decisions are final and binding on all matters relating to this Contest. Sponsor reserves the right not to award all prizes if, in its sole discretion, it does not receive a sufficient number of eligible and qualified entries.

PRIZE & ODDS: **Six (6) winners of the Wolverine RMAX Adventure Ride Contest** win one (1) trip for two (2) to Yamaha's Colorado Adventure Ride in Taylor Park, Colorado June 7-10, 2024 (Approximate Retail Value "ARV" \$6200), which includes round-trip airfare within the continental U.S. to & from Gunnison, CO (ARV \$3000); shuttle to and from the airport to the hotel (ARV \$300); hotel lodging, one (1) room for three (3) nights (ARV \$600); all meals starting at dinner on Friday (6/7) and ending after breakfast on Monday (6/10) (ARV \$2000), a gift from Yamaha ARV (\$300) and the use of a Yamaha Side-by-Side vehicle for the riding portion of the trip. This trip includes 1.5-2 days of Side-by-Side riding, so participants agree that by entering this contest, they are willing and able to participate in said activity. **Six (6) winners of the Tenere 700 Adventure Ride Contest** win one (1) trip for one person (1) to Yamaha's Colorado Adventure Ride in Taylor Park, Colorado June 7-10, 2024 (Approximate Retail Value "ARV" \$3550), which includes round-trip airfare within the continental U.S. to & from Gunnison, CO (ARV \$1500); shuttle to and from the airport to the hotel (ARV \$150); hotel lodging, one (1) room for three

(3) nights (ARV \$600); all meals starting at dinner on Friday (6/7) and ending after breakfast on Monday (6/10) (ARV \$1000), a gift from Yamaha ARV (\$300) and the use of a Yamaha Tenere 700 motorcycle for the riding portion of the trip. Winner must be 21 years of age or older. This trip includes 1.5-2 days of motorcycle adventure riding, so participants agree that by entering this contest, they are willing and able to participate in said activity, that they have a valid motorcycle license, and are proficient in riding a motorcycle both on and off road.
